



# MEMBER TERMS & CONDITIONS

Eligibility	Application process	Membership period
Membership is open to persons aged 18 and over	All applications must be completed truthfully	Membership runs for 12 months from date of acceptance
Junior membership available for those under 18 with parent/guardian consent	Payment of membership fee is required upon acceptance	Renewals must be completed by the membership expiry date
The Committee reserves the right to refuse membership	Membership cards are non-transferable	Lapsed memberships may require a new application

## General Conduct

- Members must behave in a respectful manner
- Abusive language or behaviour will not be tolerated
- Members are responsible for their guests' conduct
- Club property must be treated with respect
- Members must follow staff instructions
- Smoking / vaping only permitted in designated outdoor areas

## Guest Policy

- Members may sign in up to 2 guests per visit
- Guests must be signed in to visitor book
- Members must remain with their guests
- Guests must observe all club rules
- Guest entry fees apply where specified

## Dress Code

- Clean, neat and appropriate dress is required
- Management reserves right to refuse entry
- Specific event dress codes must be observed

# Facilities and Events

## Opening Hours

- Club opening hours as displayed on Facebook
- Hours may vary for special events
- Last orders will be called at management's discretion
- Members must leave premises promptly at closing

## Event Booking

- Advance booking recommended for events
- Cancellation policy applies to paid events
- Member rates only apply to the card holder
- Event tickets non-refundable unless specified
- The Club reserves the right to alter or cancel events

## Function Room Hire

- Available to members at a reduced rate
- Advance booking is required
- A deposit is required to secure the booking
- Cancellation charges may apply
- External catering and entertainment are subject to approval and relevant insurances

# Disciplinary Procedures

## Violations

- Breach of club rules may result in:
  - Verbal warning
  - Written warning
  - Suspension
  - Termination of membership
- Serious misconduct may result in immediate expulsion with no refund

## Appeals Process

- Appeals must be made in writing within 14 days
- Appeals reviewed by Committee
- Committee decision is final
- Members may have representation at hearings

# Payment and Fees

## Membership Fees

- Set annually by the Committee
- Must be paid in full upon application/renewal
- Non-refundable unless specified
- Methods of payment as specified by the Club
- Late payment may incur additional charges

## Event Payments

- Must be paid at time of booking unless specified
- Member rates only with valid membership
- Refunds at management discretion

# Club Liability

## Personal Property

- Barnbow Social Club is not responsible for loss or damage to personal property
- Lost property is held for 30 days only
- Vehicles are parked at owner's risk

## Personal Injury

- Members/guests use the facilities at their own risk
- Club insurance covers statutory requirements
- Accidents must be reported immediately and logged in the accident book

# Data Protection

## Member Data & CCTV

- Personal information is processed as per the Privacy Policy
- Members must consent to data processing
- Data is used only for Club purposes
- Members may request data access
- Data is retained per legal requirements
- Club premises are under CCTV surveillance
- Footage is retained per legal requirements
- Footage may be shared with authorities

# Amendment of Terms

- Barnbow Social Club reserves the right to amend terms
- Changes will be notified to members
- Continued membership accepts changes
- Current terms displayed in the Club
- A copy is available on request

# Licensing

## Alcohol Service

- Barnbow Social Club operates under a premises license
- Management may refuse service
- Valid ID may be requested
- No alcohol is permitted to be brought on to the premises
- No alcohol should be removed from the premises

## Children

- Under 18s must be accompanied by a responsible adult
- Age restrictions apply to certain events
- Children must be supervised at all times

# Termination

By Member	By the Club
Written notice is required	The Committee may terminate membership
No refund of membership fee	Written notice will be provided
All club property must be returned	An appeals process is available
Outstanding accounts must be settled	No refund if terminated for misconduct
